Name Change:

This notification is to inform you of our legal name change from "Actel Corporation" to "Microsemi SoC Corp." due to the acquisition by Microsemi. The new legal name, "Microsemi SoC Corp.", has been updated with the Internal Revenue Service (IRS), Dun & Bradstreet (D&B) and DLA Land and Maritime.

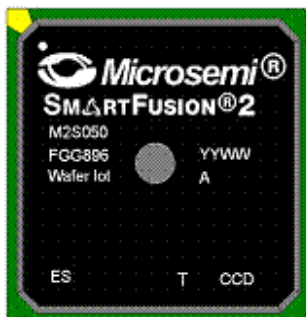
