### **Q1) What has changed?**

#### **Answer:**

- Company Legal Name from “Actel Corp” to “Microsemi SoC Corp.”.
  - Customers are advised to use the new company name “Microsemi SoC Corp.” effective immediately. Purchase Orders received 30 days after this notification must be made to the new name.

### **Q2) What is not changing?**

#### **Answer:**

- The Federal Tax/Employer Identification Number (EIN) has not changed, it is 77-0097724
- The DUNS Number has not changed, it is 148222045
- The CAGE Code has not changed, it is 0J4Z0
- The topside product marking is not being changed for any product that is currently marked with the Actel logo
- Manufacturing Place: No change
- Manufacturing Equipment: No change
- Manufacturing Process: No change
- Raw Materials: No change
- Manufacturing Workforce: No change
- Inspection Method: No change
- Quality System: No change

**Q3) Are you also referred to as “Microsemi SoC Products Group”?**

**Answer:** Yes, on web collateral and customer presentations we are also commonly referred to as “Microsemi SoC Products Group”. This is a marketing name for our division. However, all PO’s must be made out to our legal name.

**Q4) What is the company name on quality certificates?**

**Answer:** We are in the process of updating the company name on quality certificates. These can be downloaded from our website ([Link to webpage](#))

**Q5) Has the division location changed?**

**Answer:** In April 2012 we relocated to 3850/3870 N. 1st St., San Jose, CA 95134, 10miles away from our previous location (2051/2061 Stierlin Court, Mountain View, CA 94043). Relocation to the new facility was intended to maintain or improve current operational capabilities and consolidate with other Microsemi divisions in the area. PCN1202 (GIDEP SC7-C-12-02) was issued in January 2012. Our San Jose address on the quality certificates and other documents is being updated.

**Q6) What are the major differences between the Actel and Microsemi standard sales terms and conditions?**

**Answer:**

- **TERMINATION AND CANCELLATION.**

IS: Buyer may terminate a Purchase Order in whole or, from time to time, in part upon sixty (60) days advance written notice for standard goods and one hundred twenty (120) days advance written notice for Custom Products.

- Note that the Termination and Cancellation policy listed in any current contracts signed for an officer of Microsemi based out of corporate headquarters in Aliso Viejo, CA, would take precedence over Microsemi’s general Terms and Conditions.

- **TERMS OF SHIPMENT.**

IS: All shipments are made Ex Works. Title and risk of loss or damage shall pass to Buyer at the Ex Works named site (either our San Jose warehouse or the Hong Kong warehouse).

WAS: Change from FCA - FREE CARRIER (FCA-SFO), the seller is responsible for the arrangement of transportation. However, the seller would be making the arrangements on behalf of the buyer. Customers using Freight Forwarders, will now be responsible to arrange for pick-up of their orders at our warehouse (San Jose or HK).

- **WARRANTY**

IS: All Unassembled Semiconductor Devices (Die or Wafer Form) - thirty (30) days; Assembled Semiconductor Devices and Electronic Components - one (1) year. Seller provides no warranty for (a) Software or Software development systems which are supplied free of charge to facilitate Buyer’s use of associated Products, (b) prototypes of Products, (c) evaluation boards for Products or (d) Products subject to development or experimental work, all of which being supplied “AS IS, WITH ALL DEFECTS”.

WAS: 3 months warranty for Eval boards/kits to no warranty.

**Q7) Will my Department of Commerce or Department of State license be affected by the name change?**
