Subject: Changes to Business Relationship with Microsemi Corp. - Analog Mixed Signal Group

Dear Valued Customers,

With this letter, Microsemi Corp. - Analog Mixed Signal Group would like to inform you of important changes to its business that will take effect on **October 6, 2017**.

Microsemi Corporation is in the process of consolidating some of its subsidiaries to streamline processes and to improve utilization of its existing resources, including its Enterprise Resource Planning (ERP) system. As part of this effort, some of the product lines under Microsemi Corp. - Analog Mixed Signal Group, also referred to AMSG, will be consolidated into another existing Microsemi Corporation subsidiary, Microsemi SoC Corp. (the "Company"), effective **October 6, 2017.** These products are listed in Appendix 2, attached hereto ("Transferred Products"). Note: there are no changes to manufacturing locations, processes, equipment, and personnel. Quality Certificates will continue with the AMSG name until recertification in 2018.

We hope to provide you with a seamless transition and minimal impact to your business. Your contact with our organization will remain unchanged during and after the transition.

The following changes will apply during and after the consolidation of the Transferred Products to the Company:

Orders/Backlog

- The consolidation of the Transferred Products to Microsemi SoC Corp will require the Company ERP system to shut down from October 1st to October 5th, 2017 ("Transition Period"). Should you wish to receive the Transferred Products ahead of their original delivery schedule, please contact your sales representative.
- Orders for any Transferred Products received during the Transition Period will be held until we complete the transition. Shipments of Transferred Products will resume after the Transition Period. Please expect delays in any new or change order confirmations during or after the shutdown period.
- All new orders for Transferred Products placed during or after the Transition Period must be issued to "Microsemi SoC Corp."
- Please send orders to <u>SJSoC.FAX.Sales@microsemi.com</u>.



- For shipments made after the Transition Period, packing slips and shipping documents will bear the name, Microsemi SoC Corp. If you wish to re-issue these orders under Microsemi SoC Corp. in your system, please work with your Sales Representative.
- Order acknowledgment and shipping document format and numbering sequence will follow that of Microsemi SoC Corp. format.

Invoices/Payments

- All invoices for purchases of Transferred Products will be issued under the name Microsemi SoC Corp. after the Transition Date.
- Banking information has changed. After the Transition Date, please send all payments for Transferred Products to Microsemi SoC Corp. as noted on the invoices. Please refer to the additional information in the Appendix 1, attached hereto.
- Send billing or accounts receivable related inquiries to AR SOC@microsemi.com
